TRIP CANCELLATION & INTERRUPTION

- Sickness, injury or death of you, a family member or traveling companion
- Uninhabitability of the destination vacation home caused by a natural disaster
- Uninhabitability of your primary residence or your traveling companion's primary residence caused by natural disaster
- A named hurricane or other natural disaster
- Mandatory evacuation
- Obstruction of public roadways due to Adverse Weather or Natural Disaster
- Military leave revocation or reassignment
- Employer termination or layoff after 1 year of employment
- Primary or secondary school year extension
- Required to serve on a jury
- Traffic accident while en route to destination
